come my attention that there may be some



questions relating to the Pescara Lake Homeowners Association. Following are a few facts to clarify:

- Under Statute 723, there is a requirement for two-thirds of the lots to sign in writing that they are in favor of having an HOA, the HOA must be incorporated as either a profit or non-profit. All of this was done when the Pescara Lake HOA was created. The process was guided by legal counsel. Following the incorporation, resident owners have the option of joining the HOA. All lots are eligible to join the HOA. There does not seem to be any requirement for a minimum number of lots that must be members for the HOA to be legal.
- The HOA By-laws were updated a few years ago and reviewed by Lee Jay Colling who was an attorney specializing in Mobile Home Law. He also worked with the State legislature on matters regarding Mobile Homeowners' rights.
- Every lot was delivered a copy of the By-laws and told to pass them on to the new owner, along with the Prospectus, if they sell their unit.
- Negotiation with the Owners: In a negotiation you must each have something to give. As tenants in this park, we have nothing to give so we could not have a true negotiation.
- We have had a representative from the HOA meet with management semi-regularly to discuss the concerns and needs of the park and its residents. This process is currently being formalized and will have minutes of its meetings to review and be sure that there is follow-up.

HURRICANE SEASON IS UPON US!!!!!

Yes, we were hit hard last year. Let's all prepare for storms this year!!

You will find information regarding shelters and what to do later in the Tidings.

I will be running this information throughout the hurricane season.

Hurricane Safety Checklists

The most important thing you can do as hurricane season approaches is to get yourself, your family and your home prepared.

By starting early, you'll avoid the rush at home supply stores, grocery stores and other venues typically crowded and often chaotic when hurricane watches and warnings are issued.

You should stock six basics for your home: water, food, first aid supplies, clothing and bedding, tools and emergency supplies, and special items. Keep the items you would most likely need during an evacuation in an easy-to carry container. Possible containers include a large, covered trash container, a camping backpack, or a duffle bag.

Food and Water

Water

- Store water in plastic containers such as soft drink bottles. Avoid using containers that will decompose or break, such as milk cartons or glass bottles. A normally active person needs to drink at least two quarts of water each day. Hot environments and intense physical activity can double that amount. Children, nursing mothers, and ill people will need more.
- Store one gallon of water per person per day.
- Keep at least a three-day supply of water per person (two quarts for drinking, two quarts for each person in your household for food preparation/sanitation).

Food

Store at least a three-day supply of non-perishable food. Select foods that require no refrigeration, preparation or cooking, and little or no water. If you must heat food, pack a can of Sterno. Select food items that are compact and lightweight. Include a selection of the following foods in your Disaster Supplies Kit:

- Ready-to-eat canned meats, fruits, and vegetables
- Canned juices
- Staples (salt, sugar, pepper, spices, etc.)
- High energy foods

- Vitamins
- · Food for infants
- Comfort/stress foods

EMERGENCY SHELTERS

- Shelter openings vary with each emergency. These shelters are hurricane evacuation shelters, not tornado shelters, cold weather shelters or flood shelters.
- Stay tuned to local media to determine which shelters are open. Shelters only open when all other local resources are expected to be expended.
- Be aware of which shelters are pet friendly. If you plan to go to a pet-friendly shelter, please be familiar with the Pet Requirements for Shelters (below) in advance.
- Sign up for the Special Needs Registry if you do not have transportation to get to a shelter and will need assistance.
- Public shelters should be a last option. It is always recommended to stay with family and friends if possible when you're told to evacuate.

Do not go to the shelter until local officials announce, through the media, that the shelter is open.

WHAT TO BRING TO THE SHELTER

In addition to your emergency supplies (food, water, medicine, flashlights, batteries, first aid kit, etc.), the following are good items to bring with you if you must evacuate to a shelter:

- Pillows, blankets, sleeping bags or air mattresses
- Extra clothing, shoes, eyeglasses, hearing aids (and batteries), etc.
- Personal toiletries, towels
- Folding chairs, lawn chairs or cots Personal hygiene items (toothbrush, toothpaste, deodorant, etc.)
- Quiet games, books, playing cards and favorite toys for children
- Important papers and irreplaceable keepsakes (driver's license, special medical information, insurance policies and property inventories, photographs)

PET SHELTER REQUIREMENTS

Pet sheltering requirements and rules are important during disaster situations. Your cooperation in making a pet friendly shelter environment enjoyable is appreciated.

- Pet(s) must arrive with a carrier or cage. Cages will not be available on site.
- Pet(s) must remain in carrier (except at scheduled exercise times).
- Owners must provide pet food and other pet supplies

as needed.

- Owners must provide certification that pet(s) are current with rabies vaccination
- Owners will not permit other shelter occupants to handle or approach pet(s).
- Owners are responsible for the care, feeding and handling of their own pet(s).

PET SURVIVAL KIT FOR PET-FRIENDLY SHELTERS

- Proper ID collar and rabies license tag
- Carrier or cage
- Water and food bowls
- Medications
- Food supply to last about three days
- Special care instructions
- Newspapers/plastic bags for waste disposal
- Toys and comfort items
- Muzzles, if necessary
- First aid supplies
- Manual can opener
- Proper ID on all belongings

- (3) Forgot to sign up? Feel free to attend but understand that we haven't purchased food for you.

POTLUCK & SUMMER COOK OUTS Here's How We Do It

When - Where - Who - How For 6 months, from October through March, the HOA sponsors a Potluck Supper on the 3rd Thursday of the month. Doors open at 5pm and festivities start at 5:30pm.

The tables and chairs in the clubhouse have been set up to accommodate the number of people who have signed up. We often have between 80 and 100 attending.

The main entree is purchased by the HOA and prepared by the volunteer hosts. Everyone who has signed up should bring their own plate, glass, silverware, napkin, and beverage of choice. Each person who attends should bring a side dish or dessert with a quantity to serve at least six servings. Our emcee calls the tables in random order to fix their plates. No second plates allowed until all tables have been called. At the end of the evening, we hope everyone will pitch in to clean up their tables and any debris that has landed on the floor. This is free of charge for HOA members. Nonmembers and guests are \$7 per person. HOA Annual memberships are \$15 per person and expire on March 31.

INFORMATION REGARDING CLUBHOUSE USAGE

There may have been some recent lack of education or misinformation about Clubhouse usage for gatherings where alcohol is involved.

Per the Park Management/Owners Rules and Regulations Section 18. RESIDENT CONDUCT. Section B. "No "alcoholic beverages" as defined in section 561.01(4)(a), Florida Statutes, may be used or consumed on or in any common area or recreational facility of the Community except that such consumption or use may be allowed for HOA-sponsored functions or activities upon prior written consent of Community Management." (This can be found at the end of your prospectus)

Bottom line – If it is not an HOA-sponsored function or activity – no alcohol. If you have an idea for a gathering, for instance, a Valentine's dance, it must be brought to the HOA Board. Please note that the Rule says, "may be allowed". This is at full discretion of the HOA Board. The HOA Board must have adequate time to review the suggested event and respond to the request. At this time, the HOA Board is reviewing it's processes and will share with you when that review is completed. Feel free to approach a Board member with questions or concerns.

While some may disagree with the Rule, we must live by it or lose our privilege of having alcoholic drinks at any event.

RULES AND REGULATIONS FOR POOL

- 1. NO LIFEGUARD ON DUTY. Swim at your own risk.
- 2. Children entering the pool must be accompanied by a community resident, parent, legal guardian, or caregiver, or must be a registered authorized guest.
- 3. No running or horseplay on the pool deck and no horseplay in the pool.
- 4. Only toilet-trained children are allowed in the pool. Infants or children with "swimmer" diapers are not allowed in the pool.
- 5. One must shower prior to entering the pool. Facilities are provided.
- 6. No sitting on pool safety rope.
- 7. No pets or toys allowed in fenced pool area.
- 8. NO DIVING.
- 9. No food or drink or glass container or service vessel of any kind in the pool or on the pool deck with the exception of the marked area on the west side of the pool area to the northwest area of the painted line. Only plastic water bottles are allowed.
- 10. Pool Hours-- generally open for use from one-half hour after sunrise to one-half hour before sunset seven days a week. Hours may vary based on maintenance requirements, seasonal variations, artificial lighting, etc., or pursuant to requirements of the Manatee County Health Department.
- 11. Emergency Medical Services--dial 911. The nearest phone is in the clubhouse. The phone may only be used during office hours.
- 12. Bathing Load Only 28 people may be in the pool at one time.
- 13. No alcohol is allowed in the pool, on the pool deck, or in the fenced pool area. This restriction includes, but is not limited to, HOA-sponsored events
- 14. All guests must be registered with Management and accompanied by a Resident while in the pool or pool area.
- 15. No swimwear is allowed in the clubhouse.
- 16. Bathing attire is required in the pool and around the pool deck area.
- 17. Suntan oils are not allowed in the pool or around the pool deck area. Non-oil-based sun-protectant suntan lotions or sun-protectant sprays are allowed.




